MCFR Members Caught Voting Multiple Times!

MCFR spokesperson hurries to explain, "but just once per election"

You get the point. MCFR members have opportunities to vote at least three times this fall. Primaries have already happened. The general election will be held on Tuesday, November 2nd. And MCFR's annual election of board members and officer takes place, with mail-in ballots due by October 30.

Cast your valuable vote in MCFR's election! Your nominations committee has recruited a stellar list of candidates. At-large board positions are being contested with 9 highly qualified candidates vying for six seats. Read through their bios (be ready to be impressed) to see which candidates will best represent you and your interests. Your vote also matters to those candidates running uncontested for offices, because they gain a sense of support through votes cast.

This election season is a prime opportunity for family professionals to use our rights as American citizens "to the max".

~We can use freedom of speech to raise the level of conversation around governmental elections— putting aside empty, mean-spirited personal attacks on candidates— and instead promoting an exciting exchange of information and perspectives *on the issues*, and discovering candidates' stands on those issues. When city council candidates come to the door we can ask, "What's your vision for families in our city? What's the relationship of city government to families? What do you think the city does well regarding families? What needs to be done better? What is your action plan regarding families?" Similar questions can spur conversation with candidates for county, state and national offices.


Within MCFR we can engage in conversations about our organization's priorities. If you know of cutting-edge practices in the family field, if you have come upon meaningful research, if you have ideas for conferences or other exchanges of information among members, seek out one of your MCFR board representatives and let them know! That raises the level of conversation within our own professional organization, and helps create board action responsive to members' interests.

~We use freedom of assembly in joining together in MCFR. Our coalescence around family research and practice informs and influences decision-making in other arenas. Many of us are in other professional organizations as well, assembling around other important work, themes and issues.

~ Finally, we must exercise every opportunity to vote. The last presidential election taught us that every vote has value. Cast your valuable vote in governmental and MCFR elections! I think of voting with a sense of connectedness. If I vote, I am connected to millions of others who are voting, and we are collectively a powerful force. If I don't vote, I am connected to those who squander that precious right, a right purchased with people's lives. I'd rather be part of the first group. **VOTE.**

Christine Fehst, PhD, LPE For over 30 years, Dr. Christine Fehst has been an educator in a variety of settings, including universities, schools, corporations and communities. Carole is an Adjunct Professor at Concordia University specializing in Family Systems and Sociology, and a Graduate Advisor at St. Mary's University. She trains social workers for the State of Minnesota in the areas of child abuse and neglect.

Realizing there were no parenting classes, she went back to school to get a degree in family life education and became a certified Certified Family Life Educator. Continuing her education, she became a certified Chemical Dependency counselor, worked for Project Charlie, and created the game "Keyed up for Being Drug Free". interest in reunifying mothers with their children and preventing second generation incarceration. This interest led her to create the books, **Help for Children Whose Parent is in Prison or Jail** and **While We're Apart**. She earned her Master's Degree at St. Mary's University. She is a member of MCFR.

Elizabeth Hoodecheck

Elizabeth Hoodecheck is the **Parent Education and Family Involvement Coordinator** for School Readiness and Community Kindergarten programs of the Saint Paul Public Schools Family Education Department. She has been a Title I Elementary School Parent Educator, founder and first coordinator of the Willmar Early Childhood Family Education program, worked in Saint Cloud Area Public Schools to meet the needs of socially, culturally, and economically challenged families with young children, and was advisor to international and non-traditional students at the College of St. Benedict. They have been used in the School Readiness and Community Kindergarten classrooms as educational tools for families and have been aired on local TV Channels.

Hoodecheck earned a Bachelor of Science and Arts in psychology from the College of St. Benedict/St. John's and a Parent and Family Educator Graduate License from St. Cloud State University. She first joined MCFR in 1985 and is a current member. She is a parent of four children from six to 21 years.
